
Metinvest Business Service Wins Award for Service Provision Resilience During Wartime at Deloitte Shared Services Awards 2024

Metinvest Business Service, Metinvest Group's service company, won in the "Resilience in Shared Services" category at the Deloitte Shared Services Awards 2024. The award ceremony took place during an international conference held from 8 to 10 October in Amsterdam, the Netherlands.

business environment of customers during wartime.

The executives highlighted several key tools that ensure the Group's sustainability, including flexible management, proactive planning and innovative thinking to maintain operational continuity and stable service delivery. They also emphasised the introduction of new technologies to enhance efficiency and reduce dependence on manual operations, as well as risk management planning to safeguard resilience.

It is a strong endorsement of our sustainability strategy and expertise.
